# What will happen during the NGO Forum and 68<sup>th</sup> ordinary session of the African Commission?

## The NGO Forum

The Forum on the Participation of NGOs in the Ordinary Sessions of the African Commission on Human and Peoples' Rights (African Commission), also known as the 'NGOs Forum' is an advocacy platform coordinated by the African Centre for Democracy and Human Rights Studies (ACDHRS) to promote advocacy, lobbying and networking among and between human rights NGOs, for the promotion and protection of human rights in Africa. The NGOs Forum shares updates on the human rights situation in Africa by the African and international NGOs community with a view of identifying responses as well as adopting strategies towards the promotion and protection of human rights in the continent.

Same as the last session, this session will be hosted online and will be framed around the theme "The Africa we want: the role of arts, culture and heritage in the realization of human rights and democracy in a post-COVID-19 environment".



three main thematic areas namely:

- The Situation of Human Rights, Democracy and Rule of Law in Africa, with a focus on the implications of Covid-19 on the rights to arts, culture and heritage
- Special Interest Group Discussions, that will be divided as follows:
- Enforcement of Covid-19 measures in Africa
- Shrinking civic space and human rights defenders
- Economic, Social and Cultural Rights in Africa (with a focus on the right to health)
- Role of youths in the implementation of the African Union's Agenda 2063
- Independence of the Judiciary
- Impact of Covid-19 on elections in Africa
- Networking for Human Rights in Africa, strategies and best practices for the enjoyment of cultural rights and freedoms in the current and post-Covid-19 environment.

## • State periodic Reports (Item 6)

During this session, pursuant to Article 62 of the African Charter and State Parties obligation to report every two years on the legislative or other measures taken with a view to giving effect to the rights and freedoms recognized and guaranteed by the Charter, three countries will be reviewed:

- *Malawi*'s review will be based on its combined 2<sup>nd</sup> and 3<sup>rd</sup> report, covering the period 2015-2019 and submitted to the ACHPR in February 2020 (16 April, 9.30am to 10.30am)
- **Benin's** review will be based in its combined <u>6<sup>th</sup> to 10<sup>th</sup> report</u>, covering the period 2009-2018 and submitted to the ACHPR in August 2020 (20 April, 9am to 10.30am)
- *Niger's* review will be based on its <u>15<sup>th</sup> report</u>, covering the period 2017-2019 and submitted to the ACHPR in November 2019. (21 April, 9am to 10.30am)

## • Activity reports (Item 7)

During every session, special mechanisms from the African Commission present their activity report. These reports catalogue the activities and initiatives undertaken by each mechanism inter-sessionally:

## What advocacy opportunities does the Commission offers?

#### The situation of human rights in Africa

Under Item 3, civil society organisations with observer status have the possibility to make a statement highlighting specific issues relating to the human rights enshrined in the African Charter. It can be used to call the attention of the Commission on a specific issue or even update the Commission on an issue previously brought to its attention.

## Country review

Under article 62 of the African Charter, States are obliged to submit a report every two years on the legislative or other measures taken with a view to giving effect to the rights and freedoms recognised and guaranteed by the present Charter. During this process, civil society organisations also have the possibility to submit shadow reports ahead of the session during which countries will be reviewed in order to inform the Commission's recommendations and provides share advices to a specific State.

## Country and Special Rapporteurs mandates

- Every Commissioners has under its mandate 5 countries in Africa. During the session, civil society organisations have the opportunity to meet with the Commissioner which has their country under its mandate. It is important to seize this moment to update the mandate on the issues specific to your country and more specifically call his attention to an issue you want him to raise with the State directly or during the session.
- All year long it is recommended to civil society to share information with Special Rapporteurs. During sessions, civil society organisations can make statements during the presentation of each Commissioners, including Special Rapporteurs, activity reports highlighting important issues of interest.
