Excelencias

La presente es para instarles a rechazar cualquier intento por parte del Plenario de la Asamblea General de las Naciones Unidas de diferir el examen de partes del Informe del Consejo de Derechos Humanos de las Naciones Unidas.

Como organizaciones de la sociedad civil de todas las regiones del mundo, recurrimos al Consejo de Derechos Humanos para solicitar la protección de los derechos humanos de todos y todas. Cada año, después de mucha deliberación, debates y negociaciones sustantivas, el Consejo adopta numerosas resoluciones, mandatos de grupos especiales, informes, Procedimientos Especiales, Comisiones de Investigación y otros instrumentos y mecanismos.

La creación de un Experto Independiente para atender temas relacionados con violencia y discriminación basadas en orientación sexual e identidad de género en junio de 2016 se realizó completamente bajo el mandato y la autoridad del Consejo de Derechos Humanos. La decisión se basó en los hallazgos de dos informes A/HRC/19/41 y A/HRC/29/23 que el Consejo solicitó al Alto Comisionado de las Naciones Unidas para los Derechos Humanos. El Consejo concluyó que era preciso prestar especial atención a la protección contra la violencia y la discriminación por motivos de orientación sexual e identidad de género.

Nos preocupa que el mandato otorgado al Consejo por la Asamblea General sería fundamentalmente socavado en caso de que la Asamblea General buscara reabrir el informe anual del Consejo y seleccionar las resoluciones que apoya y las que pretende bloquear, incluso con el pretexto de diferir su discusión. En efecto, esto permitiría que todas las resoluciones del Consejo fueran renegociadas y debatidas cada año por la Tercera Comisión, lo que tendría implicaciones mucho más allá de la resolución específica que se está examinando actualmente. Si bien esta acción está dirigida específicamente en contra de la creación de este Experto Independiente, el mismo argumento podría ser utilizado para socavar cualquier otra decisión adoptada válidamente por el Consejo en cualquier momento.

Se ha sugerido que el mandato del Experto Independiente no cuenta con una base legal. La base legal del mandato es exactamente la misma que la base legal en la que se fundaron las tres resoluciones sobre la orientación sexual y la identidad de género (SOGI) adoptadas por el Consejo, incluida la presentada por Sudáfrica en 2011 y la presentada por Brasil, Chile, Colombia y Uruguay en 2014.

La designación del Experto Independiente no busca crear nuevos estándares, sino simplemente abordar, dentro del marco existente proporcionado por el derecho internacional de derechos humanos, la brecha de protección para las personas que enfrentan violencia y discriminación en base a su orientación sexual e identidad de género. En los últimos años, el Consejo ha creado mandatos de Procedimientos Especiales centrados en la discriminación sistémica, la marginalización y las violaciones de varias poblaciones que no tienen una referencia explícita en la Declaración Universal de Derechos Humanos, como las personas con albinismo y las personas mayores.

Un titular de mandato fue nombrado para la posición de Experto Independiente durante la sesión de septiembre del Consejo de Derechos Humanos por unanimidad, quien asumió el cargo y comenzó a

trabajar desde el 1 de noviembre de 2016. No hay base legal alguna en el intento de prevenir que el titular del mandato continúe llevando a cabo su importante labor. Esperamos que todos los Estados mantengan y defiendan la integridad institucional del sistema de derechos humanos de las Naciones Unidas y el principio de no discriminación en la próximo Plenario de la Asamblea General.
